Wisconsin Lawmakers Goals for 2026

Lawmakers in Madison finish the 2025-2026 legislative session this spring. As they look ahead to fall elections, both Republicans and Democrats are defining their political goals and talking points for the fall elections.

Republicans hope to maintain their legislative majority in both houses and win the open gubernatorial race. Key platform areas include tax cuts, deregulation, and crime. Democrats hope to win control of one or both legislative houses and maintain control of the Governorship after Governor Evers steps down. Their focus areas include affordability, expanding health care access, increasing environmental protections, and increasing education spending.

Republican candidates and party leaders have outlined several specific policy goals:

- Lower taxes:
 - Implementing a property tax freeze or an eventual elimination of property taxes by replacing them with a local consumption tax.
 - Expanding tax credits for low-income households and enhancing the Homestead Tax Credit to assist with housing costs.
- Regulatory Reform:
 - Reducing state regulations by 25% to boost the state's GDP.
 - Streamlining licensing for childcare providers and expanding employer-childcare partnerships.
 - Reforming zoning laws to accelerate workforce housing development.
- Public Security:
 - Improve the efficiency of crime labs in processing evidence.
 - Increase funding and resources for prosecutors across the state.
 - Focus on border security and interdicting the flow of illegal drugs into Wisconsin.

Democratic candidates and party leaders have outlined several specific policy goals:

- Affordability:
 - Addressing rising costs, stagnant wages, and making life more affordable for working families.
- Healthcare Access:
 - Expanding Medicaid.
- Education:
 - Strengthening K-12 education and supporting public schools and teachers.
- Workers:
 - Championing unions.
- Environmental Protection:
 - Focus heavily on clean water, clean energy, and climate resilience.

ACI Grade 1 Dates

- February 11th in Milwaukee
- March 12th in Woodruff
- May 7th in Fond Du Lac
- June 4th in Madison

The training course offers instruction in the fundamentals of concrete testing procedures. Emphasis is placed upon practical information and skills which will help quality-control and testing personnel do their jobs more efficiently to ensure consistent, quality concrete, and reliable test results. Testing includes a classroom session followed by a field test session.

LOCKOUT/TAGOUT SAVES LIVES!



What is Lockout/Tagout (LO/TO)?

LO/TO is a safety standard designed to help control hazardous energy to protect workers from its dangerous effects at ready mixed concrete plants. Compliance with LO/TO prevents injuries, amputations, and even death. LO/TO programs are aimed at protecting workers performing service or maintenance on machinery and equipment that may be exposed to injuries from unexpected energization, startup of machinery or equipment, or release of stored energy in equipment. In order to protect these workers, the LO/TO standard requires that all employers “establish a program and utilize procedures for affixing appropriate lockout devices or tagout devices to energy isolating devices, and to otherwise disable machines or equipment to prevent unexpected energization, start-up, or release of stored energy...”



Lockout/Tagout Recommendations

Concrete producers should implement LO/TO programs that are tailored to their concrete plants. Plans should address ready mixed concrete industry activities, such as constructing, installing, setting up, adjusting, inspecting, modifying, bypassing guards and maintaining and/or servicing machines or equipment. As well as, lubrication, cleaning, or unjamming of conveyor belts and making adjustments or tool changes to equipment at plants. All producers should reference the federal or their state LO/TO standard for specific requirements. As well, prior to work beginning, devices must be tested to ensure they cannot be turned on after LO/TO has been performed.

Actions

Considerations for safe LO/TO practices:

- Think first
- Use standardized, durable locks
- Tags should be legible, bright and identifiable
- Use only one lock per each Authorized Employee
- Eliminate spare lock keys
- Keep procedures logical and up to date
- Utilize a LO/TO Logbook
- Train all employees on LO/TO
- Verify LO/TO

SLIPS, TRIPS AND FALLS

Slips, Trips and Falls

According to the National Ready Mixed Concrete Association (NRMCA), slips, trips and falls account for the majority of all workplace accidents. During the winter months, this reality is highlighted by more muddy, wet and icy walking and working surfaces. To reduce and ultimately eliminate slips, trips and falls, and the injuries and costs associated with them, especially in the winter months, ready mixed concrete producers should take just a few minutes to assess their operations and any liabilities.



Prevention

Ready mixed concrete production facilities should have all employees review procedures at plants for walking, working surfaces and fall protection on a regular basis. Reviews should include regular inspections followed by any necessary fixes, changes or updates to surfaces.

Actions

- Think first
- Use 3 points-of-contact when ascending or descending stairs or ladders
- Keep focused on footing and hand rails
- Limit slippery or icy surfaces
- Keep surfaces dry
- Adhere to proper housekeeping
- Eliminate walking obstacles
- Spread sand and/or salt
- Use boot/shoe crampons or cleats
- Layout anti-slip mats or treads
- Maintain proper lighting
